VALPAC UPDATES

- The new qualification codes and course codes for element 005 and element 034 have been implemented in SQLValpac for 2015.
- The new education cesms have been included in SQLValpac.
- Institution names have been corrected in terms of the gazettes, e.g DUT and WSU. The change for Nelson Mandela University will only be implemented from 2016.
- The reports have been developed reflecting all the new qualification types and course codes. The B Tech, Advanced Diploma and PCGE have been separated out into their own columns for tables 2.12 and 2.13. In table 2.13 the Doctoral degree has been separated into two columns one for research and one for non-research.

Please clean up your data based on the validation reports, e.g element 018, the cesms, the qual types. Blanks have been found for element 031 and element 034. Incorrect data in element 018. Courses listed as pre-tertiary – will not be funded.
