What is a paradigm shift?

- American physicist and philosopher Thomas Kuhn: "a fundamental change in approach or underlying assumptions"
- Merriam-Webster Dictionary: "an important change that happens when the usual way of thinking about or doing something is replaced by a new and different way"
- Cambridge Dictionary: "a <u>situation</u> in which the usual and <u>accepted</u> way of doing or <u>thinking</u> about something <u>changes</u> completely"
- Urban Dictionary: "A <u>change</u> to anything being described by a person who likes to use buzzwords... Has no real meaning, but people like to <u>pretend</u> it does."

Paradigm shift: represents a fundamental CHANGE to the way we currently THINK

about or DO quality assurance



How do we think about or do quality assurance currently?

- HEQC Founding Document 2001
 - Fitness for purpose
 - Value for money
 - Transformation
 -Couched within a fitness of purpose framework
 - Phase 1 (A and B), Phase 2
- Second Cycle of Quality Assurance (Consultative Document, 2011)
- Quality Enhancement Programme, 2013-2017
- Integrated Approach to Quality Assurance in Higher Education, 2017





Our conclusion, therefore, is that yes – there is a proposed change in the way we DO – integrated – quality assurance going forward.



What does "integrated" mean to you?

Let's build a definition





- Merrian-Webster Dictionary: to form, coordinate, or blend into a functioning or unified whole: <u>UNITE</u>, or to find the <u>integral</u> / fundamental) of (something, such as a function or equation)
- Cambridge Dictionary to <u>combine</u> two or more things in order to become more effective

So what do I know for sure about IQA?

- We need to break the silos
- We need to collaborate and partner with key role players, including the CHE

 - If you are unsure benchmark yourself against your fellow institutions both national and international.

We need to internalise our institutional quality assurance mechanisms; apply informed, innovative and intelligence-driven decision-making, to achieve continuously improving and internationally comparable, quality assurance practices.
