1. Introduction and Data Presentation

- This report focusses on a snapshot of the evaluation of the HEMIS Institute 2022
- The chosen rating scale was a 5-point Likert scale:
- The results are presented as mean scores, where high scores result in high satisfaction. The highest possible score is 5 and the lowest score is 1.

2. Methodology and Data



Participation involved random sampling responses from attendees of the SAAIR HEMIS Institute 2022. The attendee population to which the survey was issued was 79 members.

Participants received a link to the online survey, which opened on 23 August 2022.



The survey secured 38 respondents.




The response rate of 38 out of 79 potential respondents was 48%. Average online survey response rates are currently around 30%.





Figure 1: Graph representing the evaluation of the Welcome and Opening


4.4. Mid-term Enrolment Planning Review/Update

4.5. HEMIS & VALPAC – Errors, Auditing, Future Changes





4.7. NSFAS Foundation Issues; NSFAS MBChB Issues





- Disappointing that no feedback from NSFAS was received in relation to attendance at the HEMIS Institute as there were a number of queries that needed NSFAS input






5.3. Impact of HEMIS data reporting to an institution's income (a perspective from a university HEMIS practitioner)

- Excellent and informative presentation.





5.6. Open Discussion: HEMIS Submission Software used by different Institutions – Discussion, issues, etc.



5.7. Student, Staff, Space & Postdoctoral HEMIS submissions: Issues for discussion to be submitted




